RE: Authority Meeting Engineers' Report

The following are summaries of CET's activities since the March 2, 2010 WTMA meeting:

WATER SYSTEM

Tapping Fee Update (1798.7002)

- ◆ CET met with Sean on 3/11/10 to show him our progress to date and to review the information we still need from WTMA. It was agreed that CET would prepare replacement cost estimates for lines and facilities where sufficient historical cost information is not available. The initial focus will be on updating the sewer tapping fee.

SEWER SYSTEM

Sewer System Capacity Analysis Act 537 Special Study(1798.0800)

- ◆ CET received the Township's resolution adopting the study and submitted 3 copies of the study to DEP on March 12, 2010.

NPDES Permit Renewal (1798.4004)

- ◆ K. Shannon reviewed Sean's draft letter to DEP, which was sent in response to DEP's February 5, 2010 from DEP. The letter included a report and schedule as to how WTMA proposes to comply with the nutrient cap load requirements set forth in the letter.
- ◆ We anticipate that DEP will issue a draft NPDES Permit to WTMA in the coming months. We recommend that CET be authorized to review the draft permit and provide comments to DEP on the Authority's behalf, since there is a 30-day public comment period after the draft permit is issued.

Tapping Fee Update (1798.7001)

- ◆ CET met with Sean on 3/11/10 to show him our progress to date and to review the information we still need from WTMA. It was agreed that CET would prepare replacement cost estimates for lines and facilities where sufficient historical cost information is not available.
- ◆ WTMA updated information in GIS, as requested by CET. Discuss status of study.
